THIS AGREEMENT DESCRIBES YOUR RIGHTS AND RESPONSIBILITIES. PLEASE READ IT CAREFULLY

From here forth Florin Marica Tennis Academy shall be referenced as FMTA.

Liability- FMTA will not accept any liability for any accident or injury, including a fatality of any Player, Guest or Visitor that may occur on the premises or within the grounds of the Academy

Conduct- FMTA will not tolerate unsportsmanlike conduct (I.E verbal abuse, visible / audible profanity, racket and ball abuse, physical abuse or any other unsportsmanlike conduct) the academy reserves the right to refuse service to anyone whose conduct is deemed detrimental to FMTA, FMTA has the right to terminate or suspend a Player for reasons relating to conduct as specified in the Academy Rules. Stop or prevent any misuse, vandalism, or unsafe acts. Report violations of these rules to the FMTA Staff.

Payments of Dues, Fees & Charges- A Player agree to pay FMTA His/ Her Lessons Dues, Program Dues and in advanced. The current number of dues for the classes is described on a separate Paper of Dues, Fees and Charges, and is subject to change. If any amount owed to FMTA are not paid on a timely basis, a Player should understand that he/ she may be charged a late payment charge in accordance with the Rules and Regulations.

Lessons Payments- A Player must acknowledge and agree that the Private Lessons, Group Lessons, and Summer Camps is considered non-refundable under any circumstances, including, termination, discharge, expulsion or suspension of a player for any reason whatsoever.

Private Lessons Cancellation- Players may cancel 24 hours before their scheduled lesson only, any player failing to do so the lesson may be charged. While we do understand unexpected events to happen, i.e. Suddenly Illness, Injuries or Family Emergencies do occur, please provide the coaching staff of FMTA as much lead time as possible to the cancellation.

Rain- In the event of rain, a Student won't be charged for his/her scheduled lesson canceled due to poor weather, in the event of rain players will receive an email notification stating that class has been canceled. Decisions are made as close to class time if the conditions are unsure. We can also be contacted directly via phone call or text message.

Parents- Parents may not interfere with the coaching staff at any time, constructive comments and suggestions are welcomed at any time directly to the Academy. We encourage Parents to keep an open mind and direct line of communication with the coaching staff

Players- Proper tennis attire is required. Street shoes, basketball or jogging shoes are strictly forbidden. ONLY TENNIS SHOES IS ALLOWED. One must wait until play has stopped before crossing behind players or retrieving a ball. Non-players must remain outside courts. Each player is asked to clean up the general area after he/she had played. Kindly follow all tennis rules for good sportsmanship and proper tennis etiquette should be observed always.

Racket- All players must have their own rackets. As for new players, they could borrow a racket on their first lesson only. Afterwards players are required to purchase a racket for use on the courts. FMTA can recommend several local as well as online shops for new players. If a type of racket is needed, FMTA staff can help with making a choice.

Personal Belongings- We, at FMTA, work hard to create a comfortable, secure and safe environment for each one of Our Players. However, it is difficult to account for each student's personal items. Therefore, it must be understood that any personal items that are brought to FMTA facilities are the responsibility of the individual who brings them. Further, it should be noted that Players should take the necessary steps to secure any of their personal items that they feel may be at risk, important items such as Personal ID, Cell Phone, etc. could be kept temporarily with us.
